053/25 Model Code of Conduct

After the Clerk had explained the reasons for the revised Code of Conduct, it was agreed to accept the Code and that it be included on the Parish Council's website.

054/25 Request for Financial Contribution Towards Cost of Cutting the John Corbett Trail in Churchyard

The Clerk reminded the meeting that the Parish Council had agreed to pay £300 last year towards the cost of cutting that part of the churchyard which formed part of the John Corbett Trail. It was agreed that the Clerk should establish how much overall the Church was paying for grass cutting before any decision was made on a contribution this year.

055/25 Speeding Issues affecting Stoke and Bentley Pauncefoot Parish Councils

After the Clerk had reminded the meeting that Bentley Pauncefoot Parish Council were looking for support from the Parish Council to get the County Council to install some speeding restrictions installed along Copyholt Lane. After discussion, it was agreed that there appeared to be little that could be done other than possibly install some 'horse warning' signs. Chris Cooke agreed to arrange this.

056/25 Parish Lengthsman's Report

Chris Cooke reported that the majority of the new HGV signs had now been installed which seemed to be working effectively. He added that litter picking was still an issue across the parish.

057/25 Correspondence

The Clerk reported that Bromsgrove District Council had just announced that the Community Infrastructure Grant was now open for applications. It was agreed that the Clerk should submit an application for the refurbishment of the play area at Stoke Heath Recreation Area.

058/25 Councillors Points of Information and Items for Future Meetings

Jean Jackson commented that the flower box at the junction of Wheatridge Road and Tythe Barn Close was falling apart and needed replacing. It was agreed that the Clerk should order a new recycled plastic flower box.

Jill Howe commented that the Ryefields Road sign had been damaged. It was noted that this had been reported to Bromsgrove District Council but no action had been taken. It was agreed that the Parish Lengthsman would repair the sign subject to the District Council being informed.
