089/25 Apologies

An apology was received from Chris Cooke (Parish Lengthsman).

092/25 Adjournment of Meeting for Public Question Time

(1) Members of the Public

The members of the public present and D/Cllr Nicholl commented in some detail with regard to the draft District Plan which was now out for consultation. D/Cllr Nicholl referred to the public meeting fixed for the 9 July at which it was hoped that a plan of action against the proposal to build 500 houses on Ryefields Farm would begin to be put in place. He added that he felt it was important to get support from local people with knowledge of planning etc as it was essential that any comments and arguments which are put forward needed to be constructive and based on factual information. Sue Abel added that she had been working on a range of questions which could used as the basis for future discussions and responses to the consultation process. The Chair added that the main aim of the meeting on the 9 July was to get the local community together.

D/Cllr David Nicholl had nothing further to add to his earlier comments regarding the Draft District Plan.

093/25 Minutes of the Meetings held on the 12 May and the 9 June 2025

The minutes of the meetings held on the 12 May and 9 June 2025 having been approved were signed by the Chair.

094/25 Draft Bromsgrove District Plan

Further to the earlier discussion on the draft Plan, the Chair suggested that the Parish Council should fund the printing of leaflets to support the work opposing the proposed development at Ryefields Farm. The likely cost would be in the region of £200/300. This was unanimously agreed.

095/25 Planning Applications

1) 25/00609/FUL - 3 Canal Cottage, Whitford Bridge Road, Stoke Prior - Replacement

conservatory roof, doors and windows

The Parish Council supported this application.

2) 25/00540/CPE - Caravan, The Laurels, Copyholt Lane, Stoke Pound - Lawful Development Certificate to establish use of land for the siting of residential caravan

The Parish Council felt unable to support this application on the grounds that they were of the view that the caravan in question had not been occupied continuously for 10 years. In addition, historic google map evidence showed that the caravan had been moved around the site over that period and not remained in its current location. The Parish Council were also concerned that the site of the caravan might be used for future development.

096/25 Urgent Decisions taken since the Council's last meeting

The Chair reported that as part of the background work relating to the proposed site for housing referred to earlier, he and asked the Clerk to check with Land Registry regarding the ownership of the site.

He then updated the Parish Council on the progress of the redevelopment of the play area at Stoke Heath Recreation Area. He confirmed that Wicksteed would be carrying out the complete project as they were the only company who were able to deliver within the required timescale.
